The purpose of this item is to approve the 2026 budget and includes the annual appropriation for 2026 of \$1,000 for the expenses of the Skyview South General Improvement District No. 15 (GID No. 15). The sum of \$40,661 is anticipated to be collected from the mill levy of 10.0 mills for fiscal year 2026. Additional miscellaneous revenue for GID No. 15 of \$8,552 is anticipated from interest income. The total 2026 revenue for GID No. 15 is expected to be \$49,213. The total amount will be used in the future to maintain and repair roads in the Skyview subdivision.
